



## CALL FOR BA, MA and PhD STUDENTS FOR THE PEERS CONSORTIUM

A new call has been announced within the framework of the ERASMUS+ PEERS consortium for the Bachelor, Master and PhD students of Ilia State University to carry out one-semester study mobility (either in spring or autumn of 2027) at the [University of Minho](#), [University of Aveiro](#) or [University of Évora](#).

**Study Level:** Bachelor, Master and PhD

**Mobility Duration:** 5 months

**Mobility Period:**

Spring Semester of the 2026-2027 academic year (from February 2027) or  
Autumn Semester of the 2027-2028 academic year (from September 2027)

**Language Requirement:** English B2 or Portuguese B2

**Study Field at Host University:** All subject areas listed in course catalogues

**Minimum ECTS:** 30 ECTS with mandatory recognition within the home study program

**Scholarship:**

- Monthly scholarship - 850 EUR

**Application Deadline:** 10 April, 2026

**Each candidate must submit only one (1) application online, indicating a maximum of three (3) options. Once the application has been submitted, no modifications will be possible. Please ensure that all information is correct before submitting the application.**

**Eligibility Criteria:**

- The student must be enrolled in Ilia State University at a relevant study level and have an active student status both during the call for applications and mobility period;
- Bachelor students must have successfully completed at least their first year of studies (min. 60 ECTS credits);
- Master students cannot implement the mobility in their last term;
- The area of studies chosen by the candidate for their mobility must be relevant to their studies at their home institution;
- The students must not have previously received an Erasmus Mundus or Erasmus+ exchange grant at the same study level;
- For PhD students, the total duration of Erasmus+ mobility (completed and planned) must not exceed 12 months.
- PhD students must not have completed and submitted their dissertation at the time of application or mobility.
- PhD students must have already defended prospectus. An exemption will be granted to doctoral students who, during the call for applications, provide written consent from the dean of the relevant faculty enabling mobility before the prospectus defense.
- PhD students can not undertake mobility if they have already completed and submitted their dissertation.
- The students should prepare a Learning Agreement indicating a minimum of 30 ECTS. All credits should be recognized at Ilia State University;
- Participants with fewer opportunities will have priority in the selection procedure
- Additionally, please check and follow other eligibility criteria of Ilia State University and PEERS consortium.

**The application will only be considered complete if all mandatory documents are uploaded; All documents should be presented in English. Documents issued in Georgian should be translated into English and certified by a notary.**

**Required Documents:**

<b>CV</b> (preferably in <a href="#">EUROPASS</a> format)
<b>Certificates of language skills (minimum B2 level)</b> <ul style="list-style-type: none"><li>• Please check the detailed language requirements for the relevant faculty at the host HEI</li></ul>
<b>Letter of Motivation (maximum one page, in English)</b>

**Proof of Enrollment issued by the university during the call period**

- If the student is failing to complete the degree within the defined terms and has to undergo additional semesters, this must be stated in the Proof of Enrollment

**Transcript of Records issued by the university****Learning Agreement filled out and approved by the Dean (for Bachelor and Master students)**

- Preliminary study plan to be developed at the host HEI (available [here](#)), duly completed, signed and approved by the Dean of relevant faculty of the home HEI. **Please consider that the study period is either Spring of 2027 or Autumn of 2027.**
- The student must indicate the courses in their LA and send it to their respective curriculum expert who will confirm the course selection by the signature of the Dean. The process of approving Learning Agreement might take several days.

**Certificate of Qualifications related to the previous cycle of studies (for Master and PhD students)**

- Diploma/s of all completed previous cycles of studies (e.g. for PhD students both Bachelor and Master diplomas)

**Preliminary Work Plan duly completed and signed by the parties involved (available [here](#)) (for PhD students)**

- The Learning Agreement must be signed by the student, home and host institutions.

**A pre-acceptance letter or invitation email issued by the host HEI (for PhD students only)****If relevant, proof of disability, social or economic vulnerability**
